Welcome to Professor Sir Mene Pangalos



EVP, BioPharmaceuticals R&D, AstraZeneca (retired in spring 2024)

Mene has overall responsibility for the company's pharmaceutical discovery research and early development activities. Since joining AstraZeneca in 2010, Mene has been instrumental in rebuilding the company's commitment to science and scientific excellence. Mene oversaw the creation of AstraZeneca's new R&D Centre in Cambridge.

Mene retains an active interest in neurodegenerative disease and neuropharmacology and continues to mentor post docs and PhD students. Mene has published more than 150 peer-reviewed articles in scientific journals and is an internationally renowned expert in neuroscience and drug discovery.

He is a leading figure in UK science, serving on several Boards. He sits on the council of the Medical Research Council (MRC), co-chairs the Life Sciences Council Expert Group on Innovation, Clinical Research and Data and is a member of the UK Life Sciences Industrial Strategy Implementation Board. Mene was recognised in the New Year 2020 Honours list with a knighthood from Her Majesty The Queen, for his services.


